Quorum: (21) members were present. A motion was made by Norman St. Arnauld, second by David Bailageron and passed to accept the June minutes as printed.

Communications:

A note of thanks was received from the family of deceased carrier Leone Counihan for the donation made in his memory to St. Bernard High School. A letter of thanks was received from St. Bernard School for that donation.

A note was received from NBA elect Rick DiCecca thanking President Daniels and the Branch for our support both personally & professionally. Rick also extend his appreciation to the stewards and officers of branch 20 for their support.

A letter was received from Branch 86 Hartford thanking the Branch for our donation to their annual MDA Golf Tournament that raised over \$6,300.

A letter was received from Director of Retired Members Ron Watson thanking the branch for our contribution from our 30th Annual LCPF Drive in May.

The Branch received a letter from the Committee of Laws dated June 18, 2018 approving the proposed by-law passed at the June 6th union meeting.

A memo dated July 27, 2018 from President Rolando was read that provided for the conversion of CCAs with 30 months or more of relative standing on September 1, 2018. This memo impacts about 40 of our CCAs. All conversions should be completed by September 30th.
